Notice of Expression of Interest -
Printing and Supply of NCERT Textbooks for Class XI

The Meghalaya Board of School Education invites Expressions of Interest from book publishers who are in the empanelled list of the Meghalaya Board of School Education for printing and supply of NCERT textbooks for Class XI for the academic year 2024 - 2025.

The list of Class XI NCERT Textbooks to be printed and supplied is enclosed herein.

Interested publishers or printers may submit their expression of interest under the following criteria and conditions.

1. **Audited Balance Sheet:** Submit audited balance sheets for the last three financial years (2020 - 21, 2021 - 22 and 2022 - 23) with a Unique Document Identification Number (UDIN).
2. **Income Tax Return:** Provide Income Tax Returns for the last three financial years (2020 - 21, 2021 - 22 and 2022 - 23)
3. **Tax Audit Report:** Include Tax Audit Reports for the last three financial years (2020 - 21, 2021 - 22 and 2022 - 23)
4. **Average Turnover:** Demonstrate an average turnover of not less than ₹8 (eight) Crores for the last three years. Attach a certificate from a Chartered Accountant with UDIN, mentioning the average minimum turnover achieved from the sale of books/publications.
5. **Experience:** Possess a minimum of 5 years of experience in publishing books for the Meghalaya Board of School Education.
6. **GST Registration Certificate:** Provide a valid GST Registration Certificate.
7. **Sample Copy of NCERT Books:** Submit a sample copy of the latest version of NCERT books with 'Meghalaya Edition' which shall be distinctly printed in the cover page of each book and 'Sale only in Meghalaya' to be printed on the cover of the back page. Depict the State of Meghalaya in terms of names, images, etc. used in the original books.
8. Interested Publishers or printer may submit their financial bid for each of the NCERT titles.
9. Undertaking to pay Royalty @ 10% of the MRP to the Board annually.
10. **Business Entity:** The bidder should be a proprietorship partnership firm or a company.
11. Undertaking to adhere to strict timelines and deliver textbooks in sufficient quantities within the specified deadlines.
12. Undertaking to comply with the content and formatting guidelines provided by the NCERT.
13. Valid Trading License from any of the District Council of Meghalaya.
14. **Local Presence:**
Physical presence: The bidder must demonstrate the ability to conduct business operations locally and provide evidence of collaboration or partnerships with local businesses, sub contractor or suppliers that have experience in similar works.
Interested parties are requested to submit their expression of interest along with the required documentation listed above by 24th May, 2023.
15. Preference will be given to those who has experience of printing, supply and distribution of NCERT textbooks.
